Street/Park Commissioner: per Mike Densic

The one dump truck is back in service. It can now help at Passive. We pulled some trees. We called Lake Township Police concerning cars going over the tracks when trains are not getting the entire way across before they stop. It is hard to know if trains are coming on the second track. This is happening more and more.

Speeding seems to be a bigger and bigger problem in the Village.

The Street Department would like to know what needs to be done for the 150th?

The Soccer Association would like the bleachers moved. We really don't want to do this before the 150th. So far, soccer does not have any games scheduled on weekends. Softball will be playing on weekends.

Lake Township will give us a price on crack sealing Main, Cherry and a few other streets. We will contract with them to do the work. Rumble strips will be going down on St. Rt. 795. Discussion Ensued.

There was a garage permit issued. The lots on Penney will be mowed on Thursday. Eric Wineland called Zoning Commissioner Mravoich on the Verizon Tower.

We received papers in the mail for the church property split. The church is donating part of their land to us. Vegetation needs to be trimmed on the corner of Bradner and Ayers so people can see.

Clerk Densic will be amending Ordinance 606 to include the cost of removal of anything of an unsightly or unsanitary nature. The cost will be \$500.00/ hour plus the cost of disposal of the item.
