

# MILLBURY COUNCIL

June 12, 2023

The Council of the Village of Millbury met in regular session on the above date at the Millbury Council Chambers with Mike Timmons, Mayor, presiding.

Council Members present: Clapsaddle, Sanders, K. Schwamberger and S. Schwamberger.

**Motion** by Sanders to approve the May 8, 2023 meeting minutes. Seconded by K. Schwamberger. Roll Call: all yea! Motion carried.

**Police Department: per Officer Lento**

There was 1 drug arrest, 5 speed, 1 telephone harassment, 1 repossession of a vehicle and 1 domestic violence in the village.

**Fire Department: per Councilman Sanders**

There were 7 EMS calls and 3 fire in the Village.

**Public Input:**

Matthew Lassiter attended the meeting and gave an update on the disc golf course that he would like to put at Passive Park. He would like to do a course preview (9 or 10 holes) at the park on August 5, 2023 for National Disc Golf Day. There will be portable baskets at this point and possible food trucks. He has already started cleaning up brush around the trees. According to Councilman Sanders this will be okay with the EPA. There is a list of things that need to be done, however.

Steve Chalfin, St. Peter's United Church of Christ, attended the meeting to give an update. The church is not closing. When and if the church closes, the surrounding property will be donated to the village. They are applying for grants to get some new playground equipment.

Maryjane Getz mentioned that the website needs to be updated.

**Street Commissioner: per Keith Nusbaum, Street Commissioner**

They are spreading stone at Veterans and Passive Park.

A sidewalk will be poured on Marilyn Ave. The cost will be \$8,900.00.

We will be getting rid of the 2007 X-Mark. We will be budgeting for a new machine next year.

There are new signs placed at Passive concerning golf carts.

There was a discussion on the assembling of the new bleachers. Street Commissioner Nusbaum said they probably won't be done until next spring.

We can do brim work for Bradner Rd. later this summer.

A fence on Wight was put up without a permit from the Village. They did get a permit from the Township. This problem is being resolved.

Two fence and 2 shed permits were issued in the Village. Several letters were sent out for different issues.

There is still a problem at 1350 South. We will be sending them an invoice for \$500.00 for not removing the disabled boat. This is a \$50.00 a day fine from June 2<sup>nd</sup> – 11<sup>th</sup>.

There is a blue pool on Snyder and Cherry that needs a permit.
