The Council of the Village of Millbury met in regular session on the above date at the Millbury Council Chambers with Mike Timmons, Mayor, presiding.

Motion Sanders by to approve the October 9, 2023 meeting minutes. Seconded by Mikolajczy. Roll Call: all yea! Motion carried.

Fire Department:

Public Input:

Matt Lassiter gave an update on the Disc Golf course at Passive Park. He had questions on where our property ends and the railroads begins. Council also gave approval to have after hours glow disc golf during the winter months with glow in the dark baskets and discs.

Steven Miles from 1350 Front St. attended the meeting asking if it were possible to purchase a ¼ acre piece of property that the village owns. Mayor Timmons mentioned we need to make sure that the proposed bike trail does not come across this piece of land. He will contact Wood County for further information. Discussion ensued.

Joe Musil from the Lake Township Fireman's Association asked the Village if they would be interested in purchasing land that is behind the firehall. It is two buildable lots and cone shaped piece of land. He will come back to the next meeting with a price. Discussion ensued.

Street Commissioner: per Keith Nusbaum, Street Commissioner

Currently still doing leaves in the village. The snow plows are on and ready to go if need be. We have plenty of salt as we did not use much last winter.
